I believe that a strong and determined mind always crosses the hurdles and reaches the destination. And when

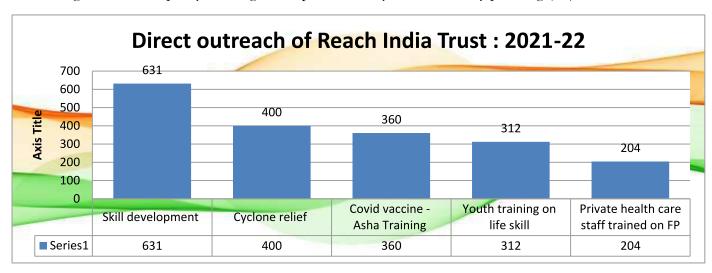

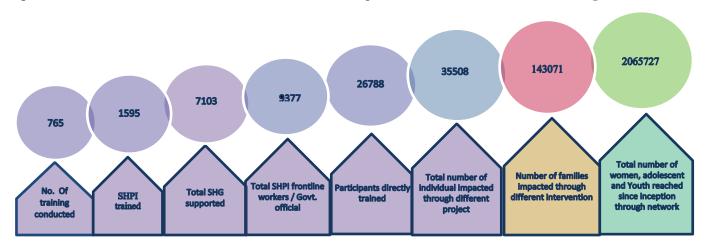
#### **OVERVIEW:**

Reach India Trust (RIT) has strived to reach out to the most pregnable, marginalised and isolated population cohorts with age specific services. It has been severally observed that from last 10 years the major thematic areas where RIT is working are skill development and livelihood promotions, reproductive sexual health & family planning and WASH.

RIT is always focused and has successfully pursued the skill development programme by providing job specific training in different sectors e.g. Retails, BPO, Health Care, Hospitality, Logistic Management etc. to the unemployed youths of urban areas of Kolkata.

The consistent achievement in the Reproductive & Sexual Health and Family Planning within the purview of the Yuvaa Project in the state of Bihar and Maharashtra is a must mention. RIT is able to reach out to a significant number of couples between 18-24 years old where the focus was to provide a free choice of contraception and bridging link with the service providers. In the process of developing the ecosystem of safe uptake of contraceptives, RIT has provided the monitoring and execution support to the implementation team and equipped them with proper knowledge and skill.

RIT has successfully completed 16 years of its journey since its inception in the year 2006 (FY-2006-07 to FY-2021-22). This is a proud moment for the organization to share its achievement stories that reached out to age specific and theme based individuals and families and requires utmost attention to acknowledge it.

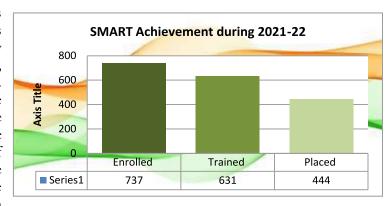


#### **DEVELOPMENT INITIATIVES**

#### 1. Enhancing skills through SMART Programme:

"Act on the educated young men, bring them together, and organise them. Great things can be done by great sacrifices only. No selfishness, no name, no fame, yours or mine, nor my Master's even! Work, work the idea, the plan, my boys, my brave, noble, good souls - to the wheel, to the wheel put your shoulders!" by SWAMI VIVEKANANDA.

Youth are the integral part of the country as they are contributing towards the nation's development. With nearly one out of every four persons between the ages of 15 and 29, India has an enviable youth population. Currently, they are estimated to constitute more than 34% of the total population. The liveliness, intelligence and quality work of the youth will take the country on the pathway of achievement. Skilful Youth community is the heart of the India. Skill and Knowledge are the main driving forces and economic growth



of any country. Reach India Trust is dedicatedly working on skill development of the Youth from urban areas. The organization is working especially in Kolkata Municipal area by partnering with Tech Mahindra Foundation since the last 9 years (2013-14) on building youth employability skills for Market oriented Training (SMART). RIT is maintaining its legacy through a strong compliance, system and quality of work. Tech-Mahindra Foundation has awarded the 4<sup>th</sup> centre to RIT at Lake Town in 2021-22. It is a proud moment for RIT that has been able to be awarded with 4 centers which is a first in case from Tech Mahindra foundation. During the financial year, RIT reached out to 737 youth from KMA area and successfully enrolled them in skilling programmes through 4 SMART Centres of Nabapally, Metropolitan, Dhakuria and Lake Town area. Among the 737 youth, 631 youth have completed the training programme and 444 youth have successfully placed in different job roles. The vocational training centres run 3 types of courses which are —

- Customer Relation and Sales (CRS)
- Logistics management
- General Duty Assistant (GDA)

#### **Celebration of Special Events**

Due to lockdown, maximum events have been celebrated virtually.

- Campus Drive A Campus Drive has been conducted in the Metropolitan Centre with 5 Companies. 100 Youth took part in the drive.
- Virtual Alumni Meet An Alumni Meet has been arranged by Tech Mahindra Foundation where around 100 Youth have participated.
- Special Day Celebration 3 SMART Centres have celebrated events like Women's Day, Teachers Day, Independence Day, Christmas virtually with the youth of the centres. Saraswati puja was also organized at the metropolitan centre.

#### RIT Smart Centers: Dhakuria



Ruksana Khatun (Prince Anwar Shah Road, Kolkata). According to her: "My father SK Alamgir is a rickshaw puller and due to our financial challenges, I couldn't complete my study after XII and was searching for a job to support my family. I came to know about RIT SMART Centre Dhakuria through Door-to-Door mobilization; joined them and successfully completed the training at Tech Mahindra Foundation RIT 3 Dhakuria Centre. After the training, I got the opportunity in 'Mochi' on 13th Mar'22 with a salary of Rs. 10,000. I'm really grateful to all my trainers who's all time motivation and extended support helped me a lot. When I got the job, my eyes were filled with tears of joy and happiness with nervousness too. Though I come from a socio-economic challenging background, The Dhakuria SMART center has changed my life and helped to enter a new phase with a positive approach. I'm grateful to RIT SMART for its contribution to make me feel strong, confident and capable to look after my family. I can say, no matter what circumstances you are in, keep faith and don't stop dreaming to achieve your goal. Life is full of miracles like the way I got to know about the SMART Centre and fulfill my dream." Ruksana is so happy and satisfied with the SMART Centre that she mobilizes and refers students to the Dhakuria SMART Centre. We have chosen her case study because of having a challenging socio-economic background; she is a dedicated, sincere and extremely hard-working lady who strives to fulfil her dream. Our best wishes to Ruksana to raise her success bar and bring more proud moments to her family.



.Pallabi Mridha (Hiranmoy Pur, Dist: South 24 Parganas), victim of domestic violence and became a single mother of 4 years old kid, joined the GDA course from the reference of Swayam. Though she was a sincere student, sometimes she missed her classes due to court cases and faculties had doubts on her continuity. But she overcame the challenges and completed the course successfully. Soon she got her first break as a GDA in Care continuum Homecare and became the bread-earner for her child. Her dedication, empathy and learning capacity is helping her to build up the experience, winning the trust of the patient and the families every day. She is now extremely focused on her career and is shining gracefully. In her version, "I want to pinch myself to ensure because this is so unbelievable. I've toiled and waited for this opportunity for so long. This moment has become so enigmatic that I'm at a loss to explain how it makes me feel and it was never possible without the help of the SMART Centre." We have chosen Pallabi's case study to showcase that a victim of her own family, turned herself as determined as shield and became a protector of self and the child. We wish her more success to continue her journey gracefully.

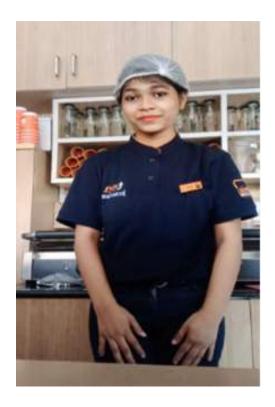


#### Smart centre - Metropolitan

She pursued her 4 months training in Customer Relationship and Sales and also graduated from SMART on CRS successfully. Her key strengths were efficiency, hard work, effort, punctuality and regularity which helped her get employment. Currently she is working at Spencer's in Quest Mall since December 2021 and from the past nine months she received fame at her office. She has been recognized by office management and felicitated her by a "Star performer Award of the Month" in Jan '22. She is from a conservative Muslim background lives in Topsia area with parents and other two siblings. Her father Mahboob Alam is a serviceman and mother Nazia Begum is housewife. Being the eldest child, she felt her responsibility towards the family and now a name of success. After she received this award, her life took a turn to culminate at the top. Through this whole journey, she got immense support from the family.

She shared her joy with us: "Thank you, Tech Mahindra, for giving me such a wonderful opportunity through training, cooperation and placement. Go at your own pace, it doesn't matter how slowly you go as long as you do not stop yourself. Aim is the end result of all true learning, so move ahead and never set back."



Tanu Mondal, a 26 years old student of Tech Mahindra Foundation has completed the logistics course from the SMART Centre Kolkata. Tanu is the sole earning member of the family, her father and elder brother (Nimai Mondal) engaged in farming and mother Putul Mondal is housewife. Since childhood Tanu had a dream of higher studies but due to circumstances, she had to quit it even after taking admission for XII. But this hardship couldn't take her ambition. She came to know about the Tech Mahindra Foundation from our door to door visit drive and also about the 4 months Certificate Course on Logistics. It was a golden opportunity for her as she was too eligible for this course. Now Tanu is working at "Tea Junction under Ambuja Neotia" as a Guest Service Executive for the past 6 months. She is grateful to the Tech Mahindra Foundation for the opportunity given to strengthen her foothold amidst a competitive job market and become a successful professional. She feels proud of completing her Graduation in Logistics from the SMART Centre. Message from Tanu:-"Me & my family overcame a lot of difficult moments. It was hard for me in every step to sustain but I didn't back off instead I fought and proved my existence. I always wanted to do my higher studies but couldn't figure out a way. Tech Mahindra Foundation showed me the path to fulfil my dream with a lot of support. My sincere gratitude to them for helping me with this golden opportunity. And, life will contain many hardships, the goal is not to back off, the goal is to fight and proves you.



#### **RIT-TMF Nabapally**



Ipsita is a 19 year old girl residing at Tollygunge area with a lower middle class financial background. Her father is a Daily wage labourer and mother is a housewife. She is pursuing graduation (1st year). When she came to our centre she was not sure whether she could continue her study or not, as her father's income was very low after COVID. It was a difficult time for them to survive. She diligently followed our classes and was placed to Spencer's first; after 3 months experience, she got a better opportunity at Metro Cash And Carry as Senior Sales Executive with salary of Rs. 13,125. Now she is a strong support for her family.



Ayush Jaiswal is a 25 year old graduate boy who belongs to a middle class family. Though previously he had done a computer course from a renowned institute but failed to crack interviews and became depressed. But with our constant counseling support and day to day classes he gained his confidence and as a result he bagged a job at Teleperformance with the salary of Rs. 14,984. He is working over there as Customer Care Associate at the elite process of Tata Play.



#### RIT - TMF Lake town



Deepika Naskar, an orphaned 22 year's old girl belongs to Dhapa. After completion of her graduation she was desperately searching for a job to survive but it was difficult to get by matching her skillset. Then she came to know about Customer Relationships and Sales course and took admission in RIT TMF Smart 4 center. She learnt about customer dealing, workplace readiness, basic computer etc. which helped her to increase confidence and to improve personality. After completion of course she got placement in Spencer's retail pvt ltd at a salary of Rs. 11,000. She thanked RIT TMF Smart 4 for providing job oriented training and feeling happy for the improvement of her economic condition.



Chumki Kundu, 25 year's old girl, lives in Kamarhati with parents. After completion of Higher Secondary, she had to discontinue study due to financial issues. Her father is a shopkeeper and she decided to stand by her family by doing a job. But it was difficult to get the job matching her skillset so she preferred to do a short term skill development course. Then she came to know about Customer Relationship and Sales Course from her friend and took admission in RIT TMF Smart 4. She worked hard to develop her skills and showed full efforts towards the course syllabus during the programme. After completion of the course she got placement in Pantaloons with a salary of Rs. 12,000. She is grateful to RIT TMF SMART 4 to help her to fulfil her dream of supporting her family.

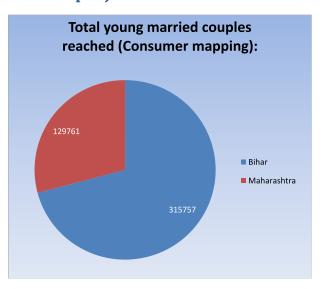


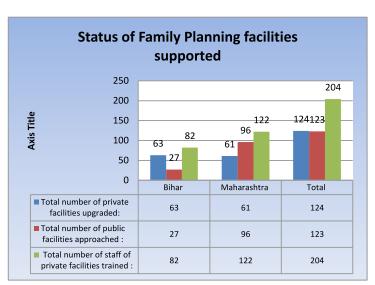
#### 2. YUVAA (Youth Voice for Agency and Access)

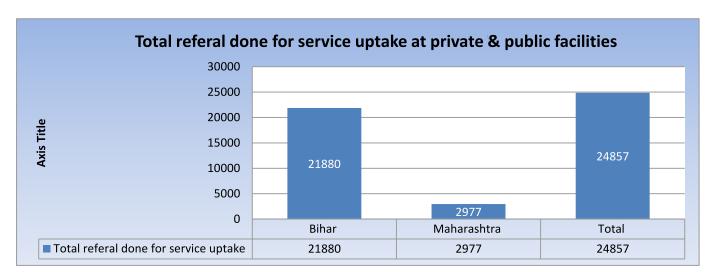
This project was implemented by Pathfinder International with few other consortium partners, Reach India trust is one of the consortium partners involved as project monitoring and support (PMS). Apart from PMS Reach India is also playing an important role in the Supply-side intervention. The organization playing a vital role in execution, DPMU at the district level, under the supportive supervision of the DPCs Project Monitoring and Support (PMS) visits to handhold home visit, counselling and group meetings have been initiated.

Significant improvement can be seen in the consumer mapping, counseling, uptake of contraception and referral service in Bihar and Maharashtra.

#### Counselling done right

Mrs. Pallavi Ahire works as a "YC" for the YUVAA project. She met Young Married Girl (YMG) of 23-year from Sarkhel, Satara. The two of them met when Mrs. Pallavi was going door to door to counsel young married women regarding family planning and contraception.

YMG tells, "When I met Mrs. Ahire for the first time, I had only heard about family planning and contraception, but I had no idea what it exactly meant." She says that it is through the counselling done by her that she got to know about the different contraception methods. She says that now she understands the importance of family planning and birth spacing better. She continues, saying that she got married when she was 20 years old. Within the first year of marriage, she conceived and gave birth to a baby girl when she was 21 years old. She and her husband had decided to only have one child. So, when Mrs. Ahire came down to explain the different methods of contraception, she also told them about the pros and cons of all the contraceptive methods. After taking some time to think it over, they, as a couple, decided to get a Long term reversible contraception.

She further adds, with a smile, "It has been 2 months since I am using contraception, but it has given me no problems till now." I am thankful for the wonderful counselling and guidance given to me by Mrs. Ahire. She not only explained what family planning is but also helped us understand the different methods of contraception, which helped me choose the one.

Mr. R Kumar and Mrs. C Devi have been working as a Yuvakaar in YUVAA Programme in Gudru, Panchayat of Guraru Block in District Gaya, and Bihar since June 2021. They got married 14 years ago and blesses with 2 children. They believe in small family happy family concept and followed the same in their life. The couple have strong view that barrier of low male participation in family planning must be address. Mr. Kumar himself gave an example to the community by permanent Non reversible contraception. They joined this project because they were not strong financially. The couple believe that that YUVAA programme is a platform for them to get improve financially. They strongly believe that husband and wife should discuss about when they want to have child, how many children they want and for delaying the pregnancy which family planning method should adopt like they plan and discuss their budget according to their income, they want to disseminate this message to all other couples also in the community. Since their joining they have motivated 80 YMC/FTP to use modern contraception.

After joining YUVAA programme they also feel privilege that in the community people know them as a social health activist and well appreciated in the community. They feel proud that they are in a job to teach people the skills to live a happy and healthy life.

#### 3. Tejaswini Project

Tejaswini' is an initiative run by Sutanutir Sakhya to empower adolescent boys and girls within the age bracket of 13 to 19 years. Reach India Trust worked in association with Sutanutir Sakhya. Under the initiative, a comprehensive curriculum has been designed on gender, sexuality, reproductive and sexual health, violence, Child and Human Rights and other protection issues and to make behavioural changes among the youth and adult community on gender equity and equality. RIT has developed the training module and conduct training sensitizes on 312 adolescent's protection, nutrition and personal health and hygiene awareness. These trainings are organized to build capacity of the youth so that they could do better for the community with support from Ward Level Child Protection Committees (WLCPCs), Health centers, Gram Panchayat, Municipality and Block level. It provides training to the community agents to develop the community and also legal support to the marginalized community women too.

# 4. Addressing the COVID-19 vaccine hesitancy among rural population in Patna, Bihar

#### **Background and context**

Covid-19, a name which has changed the entire world's life since it has evolved as a pandemic. Situation of India has become very critical during the first and second wave of covid-19. The condition of Bihar including Patna was of no difference. Bihar's Capital Patna became the worst among all other districts as it is the main transit point of the whole state. According to Coronavirus Outbreak in India - covid19india.org – 1, 46,638 people have been affected due to corona virus and unfortunately we lost 2329 people only in Patna till 15<sup>th</sup> July 2021. The loss of these lives devastated the families in various ways like mentally, financially, socially and so on. While working in the community for a longer time, RIT has understood the community more deeply at large, specifically Patna. Being the capital of Bihar, it has its special economic importance where the transit load is huge and the growing slums due to migration have also increased the vulnerability of this City.

One of the most striking factors behind raising Covid cases in India was the casual approach of the masses. From the inception of the virus, several researches conducted and some preventive measures recommended to build protection against Covid infection. Use of masks, keeping social distance and maintaining hygiene may help a person to stay safe from Covid. The most path breaking and remarkable initiative taken by the govt. of India was mass vaccination and mass awareness about the behavioural adaptation in our daily life to keep us safe. Compared to 2020, it is evident that masses are now showing leniency to undertake such measures though behavioural change is always remaining a very tough and challenging aspect for a densely populated country like India.

Considering this hard fact, Pathfinder International initiated a project named "Vaccine Hesitancy Project" to increase public confidence about the safety and efficiency of the new vaccine. The project intended to build capacity of the ASHA frontline workers and conduct road shows and campaign to educate, motivate mass including 12 volunteers as a covid Change makers at cluster of villages to support the district and block level health officers and BCMs and BHMs. The volunteers are organizing events at village level to generate demand for covid vaccine and promote community leaders and champions.

#### **Objectives:**

- Enhance COVID Vaccination knowledge, skills and situation handling
- Increase community awareness related to COVID Vaccination.
- Increase COVID vaccination coverage in 23 Blocks of Patna District

#### **Geographical coverage:**

Bihar is one of the densely populated states in the country, and being capital of the state, Patna is facing a critical situation. Inward migration, growth of improper human settlements is an added challenge for the capital. The Vaccine Hesitancy Project has been implemented all the 23 blocks of Patna District and Patna has a first dose coverage of around 76% and 58% second dose achievement against the first shot.

#### **Asha Training**

Under the project, 11 training programs out of 40 have been completed and those are organized at PHCs during the financial year 2021-22. The MOICs BCM and BHMs are involved in the program and appreciated as well. 361 ASHAs have been trained in Sampatchak, Danapur, Maner, and Dhanarua blocks. It is good to notice that 76.16% ASHA's knowledge level has increased due to participation in training programs and about 23.84 % ASHAs need more attention.

#### **Road Shows: Community activities**

International women day	International women's day on 8th March 2022 was celebrated at the community with the support of the local community, volunteers, Asha workers and Women. During the celebration, discussions included women's contribution in the Covid days, the tireless job done by the women health workers as well as women's balancing quality between personal and professional life. At the end the Asha workers shared case studies on participating in the vaccination programme followed by their views on uptake vaccination, about its benefits. While celebrating, the team was able to meet and interact with more than 50 to 60 women in the community.
National Vaccination Day	When the project was focused to increase vaccination coverage, meanwhile National Vaccination Day came up on 16th Mar '22 which has its own importance. The day was celebrated with youth, women including adolescent boys and girls. Rally was organized at the community and it continued in those areas where the community is still hesitant about vaccination. About 60 to 70 people participated in the rally to celebrate the day.
World TB day	It is a known fact that Covid affects the respiratory system and TB is infectious which is prone to affect the respiratory system. TB affected persons are more vulnerable and at high risk if they further get infection of Covid, so precautionary measures are very important. On World TB day, a community meeting and rally was organized within the community. About 100 community members attended the meeting and the rally.

#### 5. Improving outreach and quality of the FP services in the urban slums through the public health system in Patna and Gaya district of Bihar

There are many barriers to accessing and adopting contraception for young men and women. Young people

hold many myths and misconceptions about contraceptives, and they often lack information, limiting their ability to make informed choices on which method to use. With limited mobility, decision-making power, or access to quality information, young women may not afford the method of choice. In addition, cultural stigma and social barriers prevent young men and women from discussing SRH issues. YUVAA project addresses these barriers to contraceptive use among YMCs and FTPs, going beyond what has been implemented to:

#### 1) Scale-up evidence-informed practices

#### 2) Generate innovative approaches to accelerate demand for and use of contraception.

Yuvaa promotes genuine choice for young people, underpinned by a rights-based approach to SRH, applying a gender lens that addresses the multiple challenges of prevailing gender norms and a deliberate focus on youth participation. YUVAA project has tested an entrepreneurship model which is ready for scale and can be explored with frontline health care workers.

The YUVAA model under the grant is being scaled up through the urban primary health centers in Gaya and Patna district to support the scalable and sustainable approaches for enabling Healthy Timing and Spacing of Pregnancy (HTSP) amongst Young married couples and First-time parents through demand generation for modern contraceptives and promotion of HTSP and family planning as a lifestyle choice. The project aims to capacitate 300 urban ASHA's working in urban slums, establish 12 counselling centers in the select UPCs and 40 entrepreneurs among ASHA's or AWW to provide counseling and contraceptive product sales. The project will reach 24000 young couples during project tenure. The project's duration is April 2021 to April 2025. The project is supported by Ramesh and Kalpana Bhatia Family Foundation, United States.

#### Project Updates for January 2022 – 31st of March 2022

During the period, the initial level activities of the project started. This involved identifying and finalizing the implementation agency, recruiting project personnel, orientating newly recruited personnel and meeting with different stakeholders including the government's health department at the state and district level. Pathfinder conducted project planning exercises with project personnel and prepared implementation strategies, a facility assessment tool based on the project objective. The pathfinder team conducted field visits to various UPHCs for facility assessment and identification to establish counselling centres.

#### Objective of the project:

- To improve outreach and quality of FP services in the urban slums through the public health system in Patna and Gaya.
- To build the capacity of 300 ASHA/AWW to effectively counsel the young couples and support the young couple to adopt the appropriate FP method.
- To establish 12 FP counseling centres in Gaya and Patna District through Urban Primary Health Centres
- To provide FP counseling and products to 24000 young couples in the project area.



#### Major activities conducted during the January to March 2022

Significant activities conducted during the period Jan- 31<sup>st</sup> March 2022. The progress on the key activities is as follows:

#### Meeting with Govt officials:

The project brief was shared with key government functionaries at the state and at the district level. Discussions were held with State Program Manager (SPM) NUHM Bihar, Civil Surgeon Patna District, and District program Manager and City program Manager of Patna District and some of the key suggestions came from the government stakeholders.

#### Development of Facility Assessment tool for need assessment for UPHCs

Project team developed a facility assessment tool to conduct UPHCs assessment and conducted assessment of 10 UPHCs. The facility assessment tool is attached in the annexure.

#### Field visit and assessment of health centre

The details of the facility visited and assessed are as follows:





#### HUMANITARIAN INITIATIVES

The very Severe Cyclonic Storm "YAAS" made landfall on 26th May'22 at around 09:00 hrs. near South Balasore (Odisha) and Medinipur (West Bengal). The period of landfall coincided with the full moon and lunar eclipse; high spring tides created a strong storm surge that inundated the coastal districts of East Midnapur, South 24 Parganas and adjoining districts of West Bengal. In preparation for the likely devastating Cyclone Yaas, with support from Tech Mahindra Foundation, RIT has planned and executed a relief distribution camp to help the affected people of Hingaljanj.

Hingaljanj is a community development block that forms an administrative division in Basirhat subdivision of North 24 Pagans district West Bengal. Life is difficult in Kumirmari, in the Hingaljanj district of West Bengal, near the Bangladesh border. The pandemic has worsened the situation. It took the Kolkata team nearly 5 hours to reach. RIT and Tech Mahindra foundation together supported 400 families (farmers, migrant workers, daily wage labour, senior citizens and more). RIT tried to contact some local vendors for distribution purposes and they willingly held our hands and arranged to distribute the ration Kit. Local community people helped us with a lot of distribution work. Earlier we collected quotations from local vendors for distribution kit procurement.

After bearing this devastating situation, the livelihood became more difficult for the folks of this area. So when they got to know about our small initiative, they happily accepted that and kept their patience in queue and we were able to make the distribution process successful.
